**DECISION OF THE MANAWATU DISTRICT LICENSING COMMITTEE (ON THE PAPERS)**

This application was considered by the Manawatu District Licensing Committee pursuant to the provisions of the Sale and Supply of Alcohol Act 2012.

**Application**

**PREET AND PREET FEILDING LIMITED** has applied for the renewal of an off-licence in respect of premises situated at 8 Stafford Street, Feilding and known as The Bottle O Feilding.

**Inquiring Agency Reports**

***Police***

The New Zealand Police do not oppose the application.

***Licensing Inspector***

A report from the Manawatu District Council Licensing Inspector dated 28 November 2023 was received and considered. The Inspector did not oppose the application.

***Medical Officer of Health***

The Medical Officer of Health does not oppose the application.

**Local Alcohol Policy**

There is no local alcohol policy in force within the Manawatu district.

**Consideration of the application**

As no objection to the application has been filed and no matters of opposition have been raised by the inquiring agencies, the application was considered on the papers.

In considering whether to renew the off-licence, the licensing committee considered the criteria set out in section 131 of the Act.

**District Licensing Committee decision**

*Having regard to the information supporting the application and having regard to the criteria set out in section 131 of the Sale and Supply of Alcohol Act 2012 the Manawatu District Licensing Committee grants the renewal of an off-licence to **PREET AND PREET FEILDING LIMITED** in respect of premises situated at 8 Stafford Street, Feilding and known as The Bottle O Feilding, for a period of three years expiring on the 20th day of September, 2026 subject to the following conditions:*

1. No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day.
2. Alcohol may be sold only on the following days and during the following hours:  
**Monday to Sunday – 9.00 a.m. to 10.00 p.m.**
3. The whole of the premises is designated as a supervised area.
4. A Host Responsibility Policy must be maintained and displayed at all points of sale and the Licensee must ensure all staff receive training in their responsibilities and obligations under the Sale and Supply of Alcohol Act 2012.
5. There must be no sale or supply of alcohol to minors or intoxicated persons and there must be displayed at every point of sale appropriate signs detailing these restrictions.
6. Drinking water is to be freely available to customers, while alcohol is being supplied free as a sample.
7. Copy of this licence must be displayed at the principal entrance to the premises. The entrance from 8 Stafford Street is designated as the principal entrance.
